

The meeting was concluded by vote of thanks proposed by Dr. Madhukar Phad, Officiating Principal and Chairperson of IQAC.



Minutes of Internal Quality Assurance cell Meeting dated 28/01/2020 held at Meeting Hall


1. Minutes of the previous IQAC Meeting were read out by IQAC Coordinator Dr. Vijay Oak and confirmed by all the members of IQAC.

5. The IQAC Coordinator proposed that internal academic and administrative audit is to be conducted and IQAC members agreed for the same.

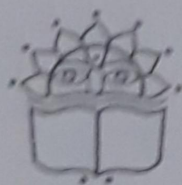
