The IQAC Coordinator collected feedback from students, parents and teachers. The feedback analysis is as follows:

### (A) Analysis of Students Satisfaction Survey:

Students Satisfaction Survey was conducted in which 50 students participated. The students were asked to respond on following criteria and their response is indicated below in tabular form:

### (B) Analysis of Parents' Feedback:

The feedback was collected from 40 parents. They were asked to respond on admission procedure, infrastructure, work culture, library services, sports facility, canteen facility, counselling, ICT, academic discipline, examination system, evaluation, career guidance and motivation for learning.
