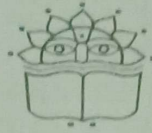

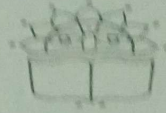
Minutes of the First Meeting for the Academic year 2023-24

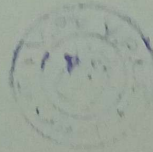

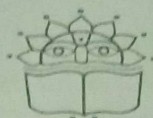

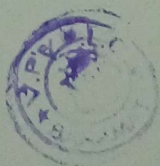
